**IMPORTANT! READ CAREFULLY**

Unique Travels & Tours, Inc., its employees, officers, directors and shareholders (collectively, “Unique”) does not own or operate any entity which is to or does provide goods or services for your program including, for example, arrangements for or ownership or control over lodging facilities, airline, vessel, bus or other transportation companies, local ground operators, visa processing services, providers or organizers of optional excursions, food service or entertainment providers, etc. All such persons and entities are independent contractors. As a result, Unique is not liable for any negligent or willful act or failure to act of any such person or entity, or of any third party. Without limitation, Unique is not responsible for any injury, loss, or damage to person or property, death, delay or inconvenience in connection with the provision of any goods or services occasioned by or resulting from, but not limited to, acts of God, force majeure, acts of war or civil unrest, insurrection or revolt, strikes or other labor activities, criminal, terrorist or threatened terrorist activities of any kind, overbooking or downgrading of accommodations, structural or other defective conditions in lodging facilities mechanical or other failure of airplanes or other means of transportation or for any failure of any transportation mechanism to arrive or depart timely, dangers associated with animals, sanitation problems, food poisoning, epidemics or the threat thereof, disease, lack of, access to or quality of medical care, difficulty in evacuation in case of a medical or other emergency, or for any other cause beyond the direct control of Unique.

No modifications to this Agreement will be binding upon Unique unless acknowledged by a signature of an officer of Unique.

Unique reserves the right to withdraw the tour, or any part thereof, and to make alterations in the program or its itinerary as it deems necessary or desirable. In case of increased costs such as for fuel or energy surcharges, Unique will increase prices accordingly.

CODE OF CONDUCT

I have read and am familiar with the Rules of Conduct with which tour participants must comply. Unique reserves the right to expel a participant from the program at their expense for any infraction thereof or for any other failure to follow directions of Unique, the sponsor or the chaperones.

BINDING ARBITRATION

Any dispute concerning, relating, or referring to this contract, the brochure, or any other literature concerning the program, or the program itself shall be resolved exclusively by binding arbitration in Bowie County, Texas according to the then existing commercial rules of the American Arbitration Association. Such proceedings will be governed by substantive Texas law.

MEDICAL RELEASE

I the undersigned will attend events being organized by Unique. In the event that I am injured and require the attention of a doctor or medical professional, I consent to any medical treatment as deemed necessary by a licensed physician or medical professional. In the event treatment is required, I agree to hold Unique free and harmless from any claims, demands, or suits for damages arising therefrom. I acknowledge that I will be ultimately responsible for the cost of any medical care should the cost of that medical care not be reimbursed by the health insurance provider. I also acknowledge that Unique does not assume any financial responsibility for any costs of medical care. Further, I affirm that the health insurance information provided is accurate at this date and will, to the best of my knowledge, still be in force. I also agree to return home at my own expense should I become ill or if deemed necessary by Unique (for whatever reason.)
